  applicant shall immediately turn down the sound level to an acceptable level agreed upon by the San
  Francisco Police Department.
- 3. At any time the San Francisco Police Department determines that the continued use of the loudspeaker permit jeopardizes public safety, the San Francisco Police Department has the authority to void the use of the loudspeaker permit.

 Applicant is responsible for maintaining sufficient event staff to ensure a safe and orderly event and imprimize impact on SFPD resources.

#### ONE NIGHT EVENT PERMIT APPLICATION INFORMATION

San Francisco law requires that the place where you plan to hold a One Night Event must conform to all health, safety, zoning and fire ordinances of the City and County of San Francisco (SFPC Sec. 1060.29). The information and questions on this sheet and the permit application will help you to determine what steps are necessary to obtain a One Night Event Permit from the Entertainment Commission.

In some cases, you must provide the Building Department, Fire Department and Health Department with certain information prior to their on-site inspections of the place where plan to hold the event. Applicants for a One Night Event Permit should contact the Building Department, Fire Department and the Health Department at least two weeks before the event. This will allow time to correct any potentially hazardous conditions identified during an inspection so that you can obtain your permit and have a safe and successful event.

You must also submit a security plan with your application that: (i) provides at least one security guard for every 100 persons authorized by the Occupancy Permit, (ii) secures a fifty foot perimeter in all directions around the location of the place of entertainment or dance hall to prevent injury to persons and/or damage to property, and (iii) provides for the orderly disbursement of persons and traffic from the event. (SFPC Secs. 1023 and 1060.29). The Entertainment Commission will notify the police station in your area and submit your security plan for their review and recommendation.

It is important that you submit all of the information required on the application and answer the questions below. Your event can be shutdown if there is inadequate security for the event, or fire hazards; unsanitary conditions or other unsafe conditions exist.
