NARRATIVE

Additional Incident: Probation Violation-26170

On the above date and time Officer Razzak #1741, Kane #4226, Elias #593, and I were assigned to the plain clothes unit at Southern Police Station. Officer Razzak received information from a Confidential Reliable Informant hereinafter referred to as a C. R. I. that there is a black female subject and black male subject known as " " selling heroin out of the Henry Hotel at 106 6th Street room 509. The CRI further advised that the room is registered to the female and that " " is on probation.

The above officers responded to the above location in order to investigate this narcotics information. Officer Kane checked the (E4) registration card for room 509 and discovered the name of (B) as registered to the room. As we arrived on the 5th floor, a black female subject later identified as approached room 509 and opened the door. As she opened the door a unknown black male subject came to the door. Officer Elias asked the subject his name and he responded, " ". Officer Elias further asked if he was on probation or parole. The subject later identified as (B) stated, "Yes, I'm on probation". Officer Elias then confirmed his probation status via Communication.

A search of and room revealed (E1) black-tar heroin which Officer Elias recovered from a dresser in the center of the room. There were three loose pieces of heroin on top of the dresser. The top dresser drawer was open and the remainder of the heroin was in a plastic sack in the drawer. Officer Elias also recovered (E2) \$131.00 (5x\$20, 1x\$10, 3x\$5, 6x\$1) in US currency in the dresser drawer, (E3) indicia in the name of in the dresser drawer, (E5) packaging in the dresser drawer, (E6) razor blade on top of dresser, and (E8) digital scale on top of dresser. was issued a property receipt for the US Currency which he refused to sign.

Once at Southern Station, Officer Kane weighed the clear plastic baggie which contained (E1) heroin from the dresser drawer and found it to weigh approximately 15.9 grams (gross weight). Officer Kane weighed the three loose pieces of heroin and found it to weigh 0.6 grams net. Based on my training and experience this is an amount I recognize as a useable quantity. Officer Kane then conducted a presumptive test on a small amount of heroin using Mecke's Reagent Test #24. The substance tested presumptive positive for the presence of heroin. Officer Kane then booked the described evidence in a narcotics envelope and later hand carried it to the Narcotics Drop Box in the basement of the HOJ for further analysis.

It should be noted that Officer Kane used a scale from our office that has not been calibrated due to fact that Southern Station's scale is inoperable. Officer Kane later booked (E7) SFPD narcotics forms at Southern Station.

A computer check of revealed that he is on active felony probation until 9/23/12 for 11352 H&S for

Based on the fact that was registered to the room and opened the room with a key, the above evidence recovered, information received, and Walton being inside the room, we believe that these subjects acted in concert to possess heroin for sales. We further believe the above evidence is indicative of a room used to maintain, sell, and package heroin.

All other evidence was booked at Southern Station. and were later booked at CJ#1

on the above listed charges with the approval of Sgt. Christ #501.
